Introduction

The UAE recognizes two Sanction Lists:

- The UAE Terrorist List - issued by the UAE Federal Cabinet
- The United Nation Consolidated List - issued by the United Nation Security Council

Both Lists Are Being Updated Periodically By The Issuing Authorities

The United Nation Consolidated List and UAE Terrorist List can be accessed from the Executive Office website UAEIEC.GOV.AE

To receive updates on both Sanctioned Lists, please subscribe to the Executive Office mailing list

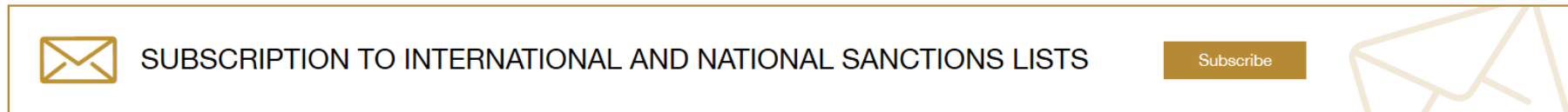

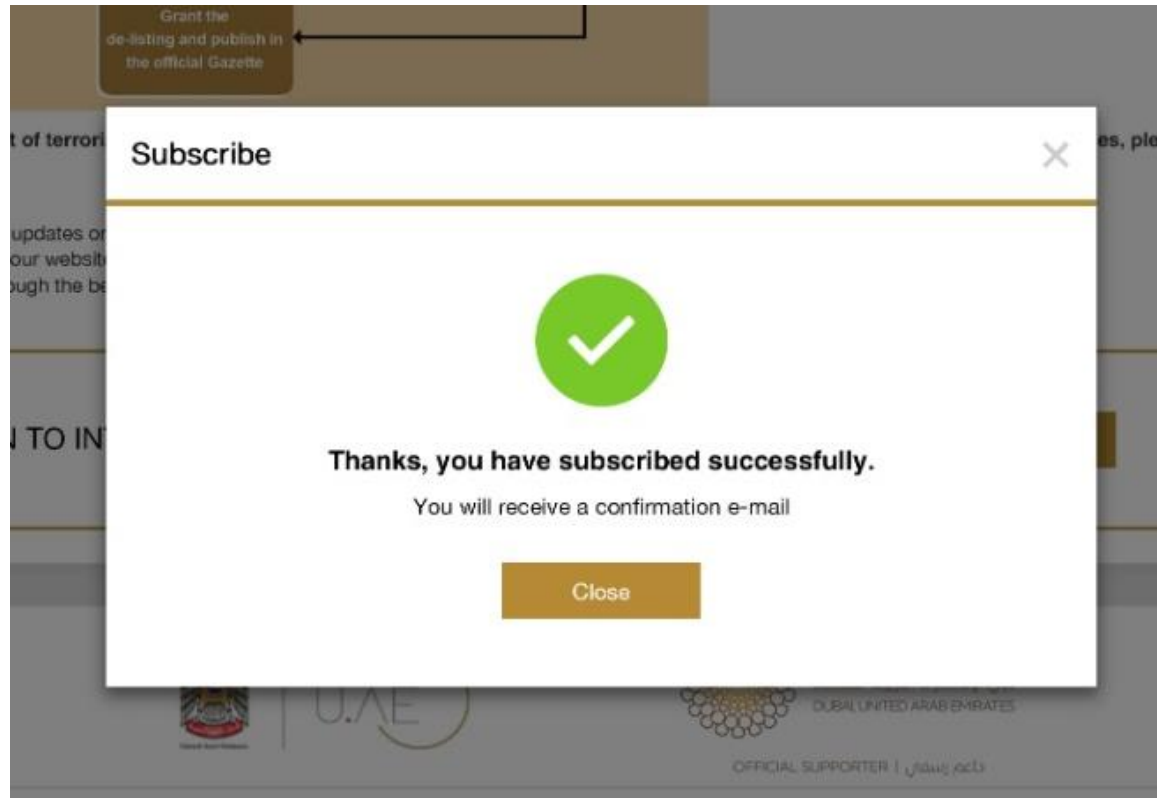
